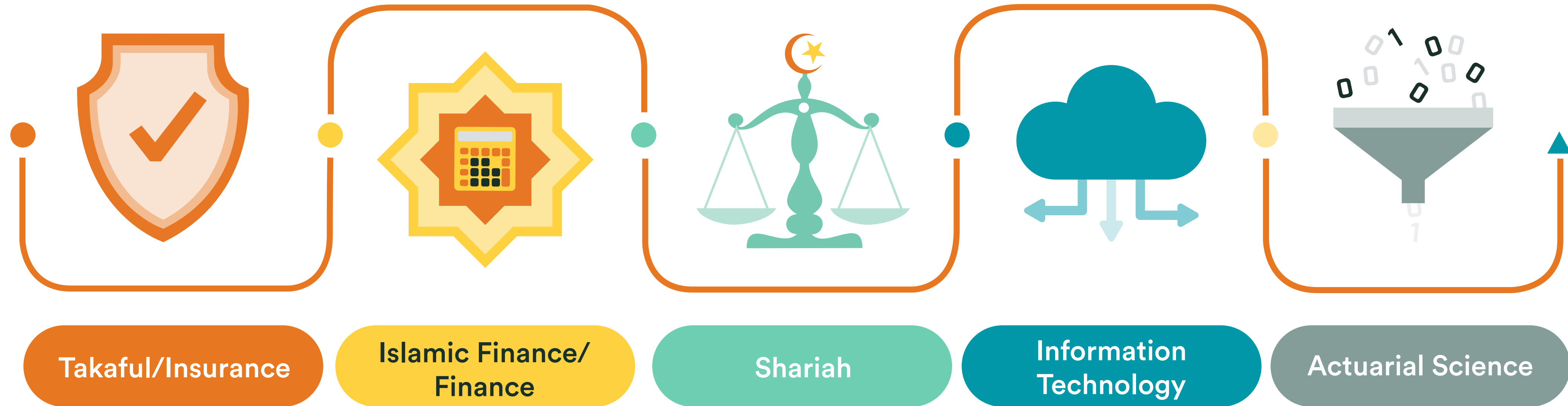
FWD Takaful Scholarship Programme

We're promoting and encouraging these students to take up study in the fields of Takaful/Insurance, Shariah, Islamic Finance/Finance, Information Technology and Actuarial Science.

Upon completion of the scholarship programme and studies, the scholar will need to serve a 3 year service bond with FWD Takaful or its group of companies. This is to guarantee employment for the scholar upon graduation. Applicant requirements

Age 21 years old and below as at January 2021.

SPM/Trial SPM Minimum 5As, including **English, Bahasa Melayu, Mathematics**. Applicants with **trial SPM results** meeting the above criteria are encouraged to apply.

STPM Minimum CGPA of **3.50** and pass the General Studies paper.

Essay Submission Applicants must submit a handwritten essay of 500 words about:

- the reasons for applying
- the benefits from the selected course
- their education and career plans

Additional Criteria

Applicants must successfully gain entry into a local public institution from the approved list of universities to pursue in any of the fields of study, as stated below.

Preference will be given to those active in co-curriculum activities.

Applicants must not be a recipient of a scholarship/loan or receiving financial assistance from any other body or organisation.

FAQs

1 Can I apply for the scholarship before being accepted into a matriculation centre or a university?

Yes, you may apply for the scholarship prior to getting a placement at the university or a matriculation centre using your trial examination results. A conditional offer of the scholarship may be given under such circumstances. The scholarship will only be awarded upon the applicant receiving an offer from the university. Therefore, the applicant will be required to inform us as soon as he/she receives the offer from the university.

2 Who can I apply for the scholarship? How do I know if I'm eligible?

You can apply for the scholarship if you're:

- A Form 5 student sitting for the Sijil Pelajaran Malaysia (SPM) exam scheduled in Feb 2021; or
- A Form 6 student sitting for the Sijil Tinggi Persekolahan Malaysia (STPM) final semester exam in April 2021.

You may apply for the scholarship if your family earns a household income of less than RM5,000 per month.

3 What should I submit with my scholarship application?

Please refer to the Application Form where we provide a step-by-step guide. Remember to read through all the requirements before applying.

4 What should I include in my scholarship essay?

Start by introducing yourself and your academic achievements, ambitions and interests. Tell us also why you need the scholarship and why you wish to pursue your education in one of the stated fields of study as well as your career goals and plan. This is your chance to showcase yourself and stand out from the rest of the applicants.

5 What will the scholarship cover?

The fully-funded FWD Takaful Scholarship Programme will cover the entire course fees that include the tuition fee, examination fees, hostel fees, living allowances, a one-time purchase of laptop, printer and books or course materials throughout the programme.

6 What is expected of me if I get the scholarship?

If you're awarded the scholarship, you need to maintain the required consistent academic scores and also good conduct which is detailed in your scholarship agreement. Please refer to the details of our scholarship programme on our website.

7 Can the scholarship be revoked?

Yes. The scholarship can be revoked if you fail to adhere to any of the scholarship requirements, such as maintaining a certain CGPA every semester or fail to maintain good conduct that is in compliance with the rules and regulations set by the matriculation centre or the university. For example, if you're found involved in drug-related activity, or activities that are not in compliance with Shariah governance, the scholarship will be immediately revoked.

8 Will I receive the scholarship if I get an offer from a foreign university?

The scholarship will only be awarded if you get an offer to further study at any of the approved lists of local colleges and universities listed in our programme.

9 How do I know if my application is successful or not?

FWD Takaful will evaluate and select the applicants starting from April until June 2021. We'll notify the selected applicants primarily by email or mail as soon as the results are finalised.

10 I've received a notification that my application is successful. Will I be receiving further details?

You'll receive an email or mail which includes a letter and the accompanying details regarding the scholarship such as your eligible expenses and the payment method, your responsibilities as a recipient, and the renewability of your scholarship for subsequent years.
